1. In the reference cited 6<sup>th</sup>, the school was granted No Objection Certificate for the affiliation of Secondary Syllabus with the **Central Board of Secondary Education, New Delhi**.

2. In the reference cited 2<sup>nd</sup>, under the provisions of Right of Children to Free and Compulsory Education Act 2009, Sec 18 read as follows:-

*“ No School, other than a school established, owned or controlled by the appropriate Government or the local authority, shall, after the commencement of this Act, be established of function, without obtaining a certificate of recognition from such authority, by making an application in such form and manner, as may be prescribed “.*

3. In the reference cited 3<sup>rd</sup>, the Government issued G.O vide G.O (Ms)No:144, School Education (GE) Department dated,18.09.2014 making it mandatory for Schools affiliated to boards other than Secondary / Higher Secondary Boards of the State Government to get necessary recognition from the Director of School Education.

With reference to your application dated 27.04.2022 and subsequent school inspection in this regard I here by convey the grant of Recognition to the **GLOBAL INTERNATION SCHOOL, M.Kovilpatti, Muraiyur Post, Singampunari Taluk, Sivagangai District (Survey No. 43/1A ,44/1A, 44/2A) for Classes LKG to XII Std for the period from 01.02.2022 to 31.01.2025.**

**The UDISE Code Number: 33231001905.**

The above recognition is subject to the following conditions:

1. The renewal recognition accorded to the school is valid from 01.02.2022 to 31.01.2025 and is to be renewed at an interval of every three years.
2. The grant of renewal recognition is not extendable and does not in any way imply any obligation to recognize-beyond class X.
3. The School shall abide by the provisions of the Right of Children to Free and Compulsory Education Act 2009 and the Tamil Nadu Right of Children to Free and Compulsory Education Rules 2011.
4. The School shall admit in pre-school / class 1 to the extent of 25 % of the strength in each class, children belonging to Weaker Section and Disadvantaged Group in the neighbourhood and provide free and compulsory elementary education till its completion.
5. The School shall maintain a separate bank account for the purpose of reimbursement.
6. The School shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.
7. The School shall not deny admission to any child :-
  - (a) For lack of age proof if such admission is sought subsequent to the extended period prescribed for admission.
  - (b) On the ground of religion caste or race place of birth or any of them.

- (a) No child admitted shall be held back in any class or expelled from School till the completion of elementary education in a school.
- (b) No child shall be subjected to pass any board examination till the completion of elementary education
- (c) No child shall be subjected to physical punishment or mental harassment.
- (d) Every child completing elementary education shall be awarded a certificate as laid down under rule 21.
- (e) Inclusion of students with disabilities / special needs as per provision of the Act.
- (f) The teachers are recruited with minimum qualifications as laid under section 23(1) of the Act:

Provided that the teachers who at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years.

- (g) The teacher performs his duties specified under sub-section ( 1 ) of Section 24 of the Act and
  - (h) The teacher shall not engage himself for private teaching activities.
9. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
  10. The School shall maintain the standards and norms as specified in section 19 of the Act.
  11. No unrecognized classes shall run within the premises of the school or outside in the name of School.
  12. The school building plan must have been approved by the current rules or G.O's. The school building or other structures and the grounds are used only for the purposes of education and skill development . Construction work within the compound should not be carried out in school working hours and safety measures in all aspects are the whole responsibility of the managements.
  13. The school is run by a society registered under the Tamil Nadu Societies Registration Act,1975 (Tamil Nadu Act 27 of 1975 ) or a public trust constituted under any law for the time being in force.
  14. The school is not run for profit to any individual, group or association of individuals or any other persons.
  15. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared. A copy of each of the Statements of Accounts should be sent every year to the Competent Authority granting recognition.
  16. The school shall furnish such reports and information as may be required by the competent authority from time to time and shall comply with such instructions of the State Government or the competent authority as may be issued to secure the continued fulfilment of the condition of recognition or the removal of deficiencies in working of the School.

B.(1) Tamil shall be taught as a subject from in Standards I to IX in all schools notified under sub clause (iv) of clause (e) of section 2 of the Tamil Nadu Tamil Learning Act,2006 (Tamil Nadu Act 13 of 2006 ) in a phased manner commencing from the Academic year 2015 – 2016 for standard I, from the academic year 2016 – 2017 for standard I and II and shall be extended up to standard IX in a like manner as ordered in a reference (5) cited.

**C. The school Management shall ensure renewal of the following Certificates as per due dates.**

- (a) License permitting the use of the School Building as Public Building under The Tamil Nadu Buildings (Licensing) Act, 1965. (Tamil Nadu Act XIII of 1965)
  - (b) Structural Stability Certificate for the school building issued by the Executive Engineers of the Public Works Department or from the Chartered Engineers in the panel of qualified and Registered Engineers maintained by the District Collector's in accordance with the Tamil Nadu Public Buildings (Licensing ) Act. 1965.
  - (c) Sanitary and Hygiene Certificate issued by the Health Officer of the locality and
  - (d) No Objection Certificate obtained from the Station Officer (Fire and Rescue) in the area. Where the School is situated.
2. The School shall abide by the provisions of the Tamil Nadu Recognized Private Schools ( Regulation Act 1973 ) and Tamil Nadu Recognized Private Schools (Regulation Act 1974 )
  3. The Certificate of Recognition issued by the department shall be subject to the fulfilment of deficiencies if any pointed out by the department at any stage / time.
  4. The Management shall rectify the deficiencies pointed out in infrastructure or administration by the authorities.
  5. The Management shall apply for renewal of recognition three months prior to the date of the next renewal.
  6. The School Management shall have the full responsibility of any court case arise in this regard. This order may be used only for the purpose of seeking affiliation to Central Board of Secondary Education as requested by the management and the management is not entitled to seek affiliation to any other Board without obtaining prior permission of the State Government.
  7. The Management shall follow the directions issued by the Government / Department from the time to time keeping in view of the safety and security of the Children and Overall administration of the School.
  8. The recognition shall be withdrawn if any contravention of the provisions of the Act, Rules or the Conditions of recognition are found and proved.
